"I am forever grateful (to the Friends of NH Drug Courts). Without them, I never would have been able to afford to do anything with my teeth. My health would have been declining. Who knows where I would be because of that. ... Thanks to the Friends, I've been able to get healthy. It's changing my life."



Surrounded by friends and family, Tanya wasn't able to smile quite as wide as she would have liked in April as she celebrated her graduation from the Hillsborough County North Drug Court. After three years and several tries to complete the diversion program, the day was filled with joy and triumph. But, with teeth worn down from years of drug use, Tanya, of Manchester, wasn't comfortable grinning ear-to-ear.

For years, Tanya, who is missing most of her back teeth, has had to avoid cold and tough foods, including her favorite steak, due to sensitivity and difficulty chewing. Tanya first started using opiates more than 25 years ago after breaking her arm playing softball as a teenager. And, over the years, her substance misuse led her to lose most of her back teeth, which has contributed to other health problems.

But, after she began drug court in 2020, things began to turn around. The diversion program connected her to substance use treatment, counseling and other supports and services. This winter, Tanya received a grant from the Friends of New Hampshire Drug Courts to help cover costs to repair and restore her teeth.

Now graduated from the drug court program, Tanya is looking forward to sharing meals with friends and family - pain free with her teeth restored.

"Since being sober I tend to laugh a lot more. ... It's going to be great not to have to worry about (my teeth)," she said.
